Implied Equity Duration: A New Measure Of Equity Risk

$$D = \frac{\sum_{t=1}^T \frac{CF_t}{(1+Y)^t}}{CF_T} = \frac{1}{Y} \left(1 - \frac{P}{CF_T} \right)$$
Where CF Denotes The Cash Flow At Time T, Y Denotes The Yield To Maturity And P Denotes The Bond Price. This Measure Of Duration Is A Weighted Average Of The Times To Each Of The Respective Cash Flows On The Bond, Where The Weights Represent The Relative Contributions Of The Cash Flows To The Bond Price.
