The Judgment If You Can Establish That The Judgment Should Not Have Been Entered. HOW DO I VACATE A JUDGMENT? To Vacate A Judgment, You Have To File A Written Request, Called An “ Order To Show Cause To Vacate The Default Judgment” With The Court That Entered It. The Most Common Bases For Vacating A Judgment Are: Apr 9th, 2024

HOW TO VACATE A DEFAULT JUDGMENT - California Courts

You “vacate The Default Judgment”, That Is, Until You Have The Judgment Removed Or Erased. To Vacate A Default Judgment, Do The Following: 1. Get The Form Called Notice Of Motion To Vacate Judgment From The Small Claims Clerk. 2. Fill The Form Out And File It With The Small Claims Clerk With A Filing Fee. You Must Do This Within 30 Days Of ... Mar 6th, 2024
