HOW TO VACATE A DEFAULT JUDGMENT - California Courts

You “vacate The Default Judgment”, That Is, Until You Have The Judgment Removed Or Erased. To Vacate A Default Judgment, Do The Following: 1. Get The Form Called Notice Of Motion To Vacate Judgment From The Small Claims Clerk. 2. Fill The Form Out And File It With The Small Claims Clerk With A Filing Fee. You Must Do This Within 30 Days Of ... Mar 2th, 2024
